Promotion Of Licensing Objectives

Describe the steps you intend to take to promote the four licensing objectives.

General: The types of regulated entertainments proposed reinstate and enhance the normal pub and family entertainments with the benefit of enhancing local facilities for social entertainment and reduce the focus on alcohol. The facilities for recorded music are proposed in support of bookings, events and the core buisness of a family friendly bar and restaurant. No new steps have been identified by my risk assessment in relation to the four licensing objectives, except as below. I have considered the terms of your local licensing policy when preparing this application. Prevention Of Crime And Disorder: Providing a 30 minute extension of opening hours after the end of the sale of alcohol, with continued sale of refreshments will promote gradual and orderly dispersal of customers. No less than seven days notice will be provided to the council and police when 'event days' are planned. No use of drinks promotions such as 'happy hours'. Active involvement in any local 'pub watch' scheme. Illumination is provided to exterior of the property. Customers will be reminded to leave quietly and respect the neighbourhood.

Public Safety: No risks that are not covered by other legislation. The pub has a health and safety policy. Public transport is good to and from the premises. the premises will promote a local licensed taxi service. The pub has a strict anti drugs policy.

Prevention Of Public Nuisance: the opening doors to the front of the premises will be closed from 23.00 alond with all windows. Any exterior garden areas will be closed from 22.00 and all customers be brought inside. Recorded music will end at 00.00 Customer departure will be actively managed. Fabric of the building retains sound. There is a lobbied entrance hall. Prevention Of Children From Harm: The restrictions set out in the Licensing Act 2003 will apply. No unusual risks of harm to children have been identified. When on the premises children must be accompanied or supervised by a parent /guardian. No cigarette machine on premises. Proof scheme or photo-id driving licenses.
